# CANDIDATE INTERVIEW QUESTIONS—PORT COMMISSIONER

- 1. Where do you see climate issues having major impacts on areas under the Port's jurisdiction and how will you guide the Port's response to those issues?
- 2. Between the Inflation Reduction Act of 2022, Infrastructure, and Build Back Better Bills, there will be a lot of federal money for local climate measures. How do you plan to tap into these funds for use by the Port? What would your priorities be for spending these funds?
- 3. How could the Port lead on collaboration between cities and towns in Pierce County to tackle common climate mitigation and climate resilience solutions as well as apply for federal IRA Act monies?
- 4. Do you have a plan to manage new development in the Port so that there can be a balance between paved space, green space, and habitat? So development does not lead to further environmental degradation through loss of green space and increased construction & traffic?
- 5. What is your plan to bring and support green, renewable energy jobs that are also highwage to the Port and County? What about green hydrogen hubs?
- 6. What are current tribal environmental concerns with the Port and how do you plan to address them?

We are concerned about preserving the existing tree canopy in Tacoma in an effort towards the city's goal of reaching 30% canopy by 2030 which has not budged from 20% since the goal was introduced a decade ago. Tacoma has the smallest canopy of all cities in western Washington. Tree planting efforts are wonderful, but it will take decades for those newly planted trees to reach their capacity, so we want to preserve what we have. Currently, and unlike other WA cities, Tacoma has no preservation plan or any meaningful enforcement for preserving existing trees. The **Tacoma City Council** is reviewing a new proposal to put some of these measures in place, but it needs citizen support and input to make it a robust and meaningful plan.

To that end, a petition is being prepared and will be available to sign soon
