# Lobby Meetings—Highlights

With US Rep. Marilyn Strickland and Staffer Liz Larter, Dec. 14

This meeting, organized and led by the CCL Olympia Chapter, was a positive encounter and centered on asking her to support the BIG WIRES bill in Congress. She and 13 of her colleagues in the New **Democrat Coalition** have already signed on in its support.

With Kiara Daniels, City Council Member At-large, Dec. 19

Council member Daniels' main focus is on community organizing, housing, and environmental justice. The group brainstormed on tree cover and building electrification, publicizing at the Sustainability Expo, and leveraging CCA and IRA funds. Daniels' community organizer background gave her a different and useful perspective on how to go about reaching communities like Hilltop about access to electrification funds, tax credits, and rebates, such as hiring local residents to go door to door. In other words, get grants and delegate to the community itself to get the word out.

# Tacoma Urban Forest Friends Petition

(12/12) "This past Tuesday, the City Council adopted ordinance TMC 9.20, the first change to our city code regarding our tree canopy in nearly 100 years. It is a solid first step on our way to 30% coverage by 2030. Trees in the public right-of-way are protected and the beginning of a Heritage Tree Program is put in place. Every council member, without exception, declared this passage as the first step toward a broader program that is not yet defined. That definition is underway and will likely be available for us to review in January and for the council to consider in March.

It is very important that we demonstrate massive support for the next steps as their definition becomes more concrete. We remain confident that the specific steps outlined in our petition are the ones the City must undertake to achieve its own goal. Our goal is to reach 2,000 signatures by the end of December." # Of Further Interest

White House, Tribes, State Enter Historic Agreement to Restore Wild Salmon

"The Biden-Harris Administration Thursday announced a historic commitment to restore wild salmon in the Pacific Northwest. The agreement brings together the federal government, Tribal nations, and the states of Oregon and Washington to invest in salmon recovery and clean energy generation, and to develop a permanent strategy for the Columbia River Basin. The partnership will also plan for the development of one to three gigawatts of clean power as a contingency should the U.S. Congress consider breaching the federal dams along the Snake River. Authority to order breach of the dams is exclusive to Congress. The four Lower Snake River dams generate about one gigawatt of power per month on average, or up to 2.3 gigawatts during periods of high demand. Gov. Jay Inslee and Sen. Patty Murray last year issued a report urging protections for salmon and advising that a breach of the dams could only occur once the dams' generative capacity and economic benefits are replaced."
