South Tacoma Mega-warehouse issue

Earthjustice, 350, and the South Tacoma Neighborhood Council have filed an appeal over a recently-approved mega-warehouse. The filing, a copy of which was made public by Earthjustice representatives, states that the appellants "challenge the City of Tacoma's decision not to require an Environmental Impact Statement for applicant Bridge Industrial's project to build one of the largest warehouse complexes in the world in a neighborhood that is already overburdened by air pollution and other environmental harms."

GLOBAL WARMING - WHAT CAN WE DO? WHAT SHOULD WE DO?

CCL has recently recognized nuclear power as a valid clean energy source. However, misconceptions about nuclear power persist amongst much of the U.S public.

Dr. Conca will give two, separate, 1-hour talks about the current state of nuclear power and how it can be an effective, safe and necessary tool in our fight against climate change.

Part 1 – The Cost, Current State and Safety of Nuclear Power vs. Other Sources

Dr. Conca will talk about the world's energy challenges with respect to geopolitics, energy poverty, climate change, WA State's unique situation, capacity factor, environmental impacts, minerals, why there are places to put each source and places not to, grid-scale storage, nuclear, cost and safety.
